√Mike has obtained a repair estimate for the flagpole in the amount of \$2,692.37. As previously discussed, we are evaluating alternative solutions due to the significant expense associated with crane usage, which is a frequent requirement given the flagpole's size. We will continue gathering quotes and assessing options, providing further updates as we progress.

√The library received the invoice for the heating unit replacement by Premistar completed in December 2024 in the amount of \$37,400.00.
